TO SELLER, SELLER'S LEGAL MANDATE AND INVOLVED INTERMEDIARIES

AS LEGAL MANDATE OF SOME VERY POTENTIAL BUYERS AND, WITH REFERENCE TO THE INTERNATIONAL <u>REGULATIONS</u> FOR AU TRANSACTIONS, WE KINDLY ASK TO SEND US A CLEAR AND BINDING FULL CORPORATE OFFER (**FCO**).

IF THE FCO IS NOT ON SELLER'S LETTERHEAD, THE PROCEDURE WILL BE AS FOLLOWS:

- 1. AFTER OUR DECISION TO GO AHEAD WITH YOUR OFFER, WE WILL SIGN A NCND/MFPA (MASTER FEE PROTECTION AGREEMENT).
 - PLEASE NOTICE THAT, WE WILL NOT WORK WITH DAISY CHAINS AND WE ONLY ALLOW 1 GROUP ON BUYER'S SIDE. IT'S THE BUYER WHO DECIDES THE SPLITTING OF THE COMMISSIONS, AS THE SPLITTING WILL BE SHARED BY WORK AND NOT BY PERSONS. WE CAN ASSURE THAT THE COMMISSIONS WILL BE PAID BUT, AFTER SIGNING A MFPA, ALL INTERMEDIARIES HAVE TO STEP ASIDE. THERE WILL BE ONLY 1 COMMUNICATION LINE BETWEEN THE PRINCIPALS OR, AT THE BEGINNING, BETWEEN THEIR LEGAL MANDATES.
- 2. NO DOCUMENTS WILL BE SENT THROUGH INTERMEDIARIES.

 - WE WILL UPDATE THE PERSON, WHO HAS SUBMITTED THE OFFER TO US BUT, WE DON'T ADMIT TO DAILY PHONE CALLS AND MAILS, ASKING HOW THE DEAL IS.
- 3. AFTER SIGNING THE MFPA, THE PERSON WHO HAS ISSUED THE FCO HAS TO SEND US HIS/HER LEGAL MANDATE LETTER OR POWER OF AUTHORITY (POA) PLUS PASSPORT COPY. A FCO, SIGNED BY LEGAL MANDATES, HAS ALWAYS TO BE ACCOMPANIED BY A MANDATE LETTER, ACCORDING TO THE INTERNATIONAL LAWS.
